RE: Reaffirmation of Accreditation (I) Category IV for Daybreak University

Dear Dr. Oh:

At its meeting on April 29, 2025, the TRACS Accreditation Commission voted to grant Daybreak University (DU) Reaffirmation of Accreditation (I) as a Category IV institution approved to offer the following educational programs:

- Intensive English Certificate (IEC) - 120 Quarter Credit Hours
- Bachelor of Arts in Psychology (BA) - 180 Quarter Credit Hours
- Master of Arts in Counseling (MAC) - 90 Quarter Credit Hours
- Post-Master's Certificate in Counseling - 36 Quarter Credit Hours
- Doctor of Philosophy (PhD) in Counseling - 93 Quarter Credit Hours
- Post-Doctoral Certificate in Counseling- 36 Quarter Credit Hours

The following areas of concentration are offered in the Bachelor of Arts in Psychology:

- BA in Psychology in Counseling Psychology and Child
- BA in Psychology in Adolescent Development and Family Studies

The following areas of concentration are offered in the Master of Arts in Counseling (MAC):

- MA in Counseling in Marriage and Family Therapy (MFT)
- MA in Counseling in Imago Relationship Therapy (IRT)
- MA in Counseling in Human Sexuality and Sex Therapy (HST)

The following areas of concentration are offered in the Post-Master's Certificate in Counseling:

- Post-Master's Certificate in Counseling in Marriage and Family Therapy (General track)
- Post-Master's Certificate in Counseling in Marriage and Family Therapy (Inner Child Therapy track)
- Post-Master's Certificate in Counseling in Imago Relationship Therapy (IRT)
- Post-Master's Certificate in Counseling in Human Sexuality and Sex Therapy (HST)

DU does not operate any Remote Locations (Instructional Sites, Extension Sites, Teaching Sites, or Branch Campuses).

DU is approved to offer its courses / program via Distance Education providing 50% or more of its courses, students, or programs through Distance Education.

DU is legally incorporated in the State of California as a not-for-profit corporation. The institution is authorized to operate as an institution of higher learning by the California Bureau of Private Post-Secondary Education (BPPE) since August 16, 2018. The institution is recognized by the Internal Revenue Service as an exempt corporation, organized under the applicable section of the Internal Revenue Code 501(c)(3). The institution is a 100% self-owned not-for profit corporation.

Since no Findings or Recommendations were given by the Evaluation Team, DU was not required to submit a Compliance Report.

Reaffirmation of Accreditation (I) is for a period of ten years (July 1, 2025 to June 30, 2035), with an Interim Fifth-Year Review (IFYR) in 2030. In order to achieve Reaffirmation of Accreditation (II), DU must complete a successful Self-Study, host an Evaluation Team, respond to the Evaluation Team's determinations, and appear before the Accreditation Commission by Spring of 2035.
